# MAHONING COUNTY PUBLIC HEALTH Case Study



### Project 1 (Winter 2019):

Mahoning County Public Health (MCPH) initiated their first project in Youngstown, OH upon recognizing the need for office furniture to support their growing team. When asked why they decided to go with Arnold's for their expansion, they replied "The fact that Arnold's carries the Sunline cubicle system."

Their initial project involved 6 Sunline Signature workstations to create an efficient and functional workspace.
